1	The total number of sections of Bal Vatika shall be restricted to 09 (three sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to XII shall be restricted to 38 of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension

compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.
